Brownfield Opportunity Areas (BOA)

CDA was awarded a NYS DOS Brownfield Opportunity Areas grant for \$254,700. As part of the project, CDA has hired AKRF consulting to identify underutilized properties and to prepare a market study for the downtown area. CDA has requested GIS information from Nassau County. A steering committee will be formed as part of the public outreach portion of the project.

Safe Routes To School

CDA is working with three Village of Hempstead Schools to provide safer pedestrian access around schools for pedestrians and drivers. NYS Department of Transportation has awarded design, construction and education funding for David Paterson, Jackson Main, and ABGS Middle School. CDA met with two school principals in June to discuss education and construction timeframes.

Main Street Beautification & Pedestrian Access Enhancement

The Main Street Beautification and Pedestrian Access Enhancement Project construction has been advertised. The Village will select the contractor once NYS DOT has approved the procurement process. CDA will use CDBG funds to hire a Construction Inspection engineer to oversee the construction work.

Residential Rehabilitation

CDA's residential rehabilitation program offers Community Development Block Grant funds for eligible senior citizens age 60+ and/or handicapped persons for home repairs, energy conservation, remediation of code violations and to make handicap accommodations for homes in the Village of Hempstead. LUIS FIGUEROA **Local Initiatives Support Corporation Grant**

> CDA is working with the Building Department to update the Village's property tracking software. This information will be used to combat vacant homes in the Village. One initiative under this grant is to identify homeowners that need foreclosure prevention assistance. CDA has partnered with Long Island Housing Partnership and will schedule foreclosure prevention sessions to help homeowners at risk of foreclosure.

DRI grant

The Governor has announced the 2nd round of the Downtown Revitalization Initiative. On June 14th CDA submitted the Downtown Revitalization Initiative grant application to the Long Island Regional Economic Development Council.

Public Service Organizations

CDA is starting to schedule visits to programs that have been awarded funding in the 2016-2017 year.

Agency Audit

The auditors are working with CDA the week of July 10th. Audit and Finance Committee members will meet in mid-August to review the audit report. The Audit report will be reviewed and presented to the full CDA Board in late August and submitted to NYS Comptroller prior to Sept. 1st.
