Position Summary:

The Construction Trainer of YouthBuild Long Island is responsible for teaching and training cutting-edge construction practices to opportunity youth ages 18-24 related to energy efficiency, renewable energy, and recycled materials. Also, responsible for maintaining safe worksite practices, providing direct instruction and work-based learning supervision, maintaining cohesive program implementation, and providing training and leadership development opportunities. The Construction Trainer works closely with general contractors, and sub-contractors to assist in project completion provide supportive guidance and encourages the development of personal and leadership skills of all participants.

- 1. Participate in the development of project-based curriculum that includes construction.
- 2. Assist in the teaching of construction skills including demolition, rough framing, roofing, drywall, finish carpentry, sheet metal, electrical, plumbing, painting, and masonry.
- 3. Assist in the implementation of the Multi Craft Curriculum and/or NCCER to train and certify program participants.
- 4. Teach cutting-edge construction practices related to energy efficiency, renewable energy, and recycled materials.
- 5. Guide participants through real-world construction tasks, ensuring they gain practical experience and build confidence in their skills.
- 6. Teach safety procedures for use and handling of equipment, tools and clean up through demonstrations, modeling appropriate procedures and supervising.
- 7. Teach appropriate ways to handle technical construction problems arising at the worksite.
- 8. Keep YouthBuild team informed about issues and needs of the participants.
- 9. Trainer will be responsible for participant oversight in the field and interface with housing department, subcontractors and inspectors.
- 10. Observe and evaluate participants at the worksite; provide hands-on assistance in training at the worksite.
- 11. Assist with testing and evaluation of student skills with the YouthBuild Team and provide regular assessments of student performance.
- 12. Document student skill attainment in coordination with the YouthBuild team.
- 13. Assist in informal personal and vocational counseling and development of participants' leadership skills in conjunction with other staff members.
- 14. Enforce rules for behavior and procedures for maintaining order among the students.
- 15. Use computers, audiovisual aids, and other equipment and materials to supplement presentations.
- 16. Assist in personal and vocational counseling and development of trainee's leadership skills in conjunction with other YouthBuild staff.
- 17. Keep track of all tools and equipment used on a daily basis.
- 18. Implement attendance policies and procedures consistently.
- 19. Provide classroom and administrative support, as needed.
- 20. Serve as an additional on-site safety coordinator and as a mentor to YouthBuild participants.
- 21. Attend regularly, United Way and YouthBuild staff meetings, alumni activities, and other events as needed.
